ORDINANCE NO. 2017-1261

“SEWAGE COLLECTION FEES”

AN ORDINANCE OF THE BOROUGH OF BRENTWOOD, COUNTY OF ALLEGHENY, AND COMMONWEALTH OF PENNSYLVANIA, AMENDING THE FEES AND CHARGES TO BE ASSESSED AND COLLECTED FOR SEWAGE COLLECTION, TRANSPORTATION AND TREATMENT.

WHEREAS, the Borough of Brentwood is subject to increased costs related to the collection and treatment of sewage as a result of capital improvements to the Borough's sewer system, as required by the U.S. Environmental Protection Agency and the Allegheny County Health Department; and

WHEREAS, due to the need to fund current and future mandated sewer infrastructure projects, it is necessary for the Borough of Brentwood to increase its sanitary sewer charges by seven and one-half percent (7.5%); and

WHEREAS, said rate increase reflects a similar seven and one-half percent (7.5%) rate increase assessed against the Borough by the Allegheny County Sanitary Authority for the treatment of sewage waste; and

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Brentwood, and it is hereby **ORDAINED AND ENACTED** by the authority of the same as follows:

SECTION 1. The Borough of Brentwood shall assess a consumption surcharge fee of **\$16.34 per thousand gallons.**

SECTION 2. The Borough of Brentwood shall assess monthly service fee of **\$9.77 per household.**

SECTION 3. The rates and charges set forth herein shall take effect January 1, 2018 and shall continue in effect on a calendar year basis thereafter without annual reenactment.

SECTION 4. If any provision of this Ordinance is found by a court of competent jurisdiction or other authority to be unconstitutional, illegal, void, invalid or otherwise unenforceable, for any reason, then the remaining provisions of this ordinance shall remain in full force and effect as though said invalid, unenforceable, unconstitutional, illegal or void provision had not been included herein.


SECTION 5. Any ordinance or resolution in conflict herewith, is hereby repealed to the extent of said conflict


